ANT ETHICAL LAWS

1. CONSIDER LIFE A SACRED AND INVIOLEABLE VALUE, ALWAYS
2. CONSIDER EUBIOSIA (A-GOOD-LIFE, A DIGNIFIED LIFE) A PRIMARY GOAL TO BE CONQUERED DAILY
3. ACCEPT NATURAL DEATH AS NATURAL CONCLUSION TO EUBIOSIA
4. CONSIDER EVERY STEP OF ILLNESS REVERSIBLE
5. FIGHT SUFFERING (PHYSICAL, MORAL AND SOCIAL), YOUR OWN SUFFERING AND OTHERS', IN EVERY POSSIBLE WAY AND WITH THE SAME ENGAGEMENT.
6. CONSIDER EVERYBODY AS YOUR BROTHER OR SISTER.
7. THE SUFFERER NEEDS YOUR UNDERSTANDING AND YOUR SOLIDARITY, NOT YOUR PITY.
8. AVOID EXCESSES, ALWAYS
9. GIVE YOUR HELP TO THE SUFFERER'S FAMILY, ALSO “AFTERWARDS”.
10. YOUR HELP IS ALWAYS IMPORTANT AND REMEMBER: OUR LOT WOULD BE NOTHING WITHOUT THE LITTLE FROM MANY!

THE RIGHTS OF THE DYING

1. EUBIOSIA IS A BASIC RIGHT OF ALL HUMAN BEINGS, FROM THE TIME OF CONCEPTION UNTIL DEATH.
2. THE DYING PERSON AND HIS FAMILY ARE ENTITLED TO UNCENSORED INFORMATION, OUT OF RESPECT FOR THE INDIVIDUAL'S DIGNITY.
3. THE COMMUNITY MUST IN NO WAY AND FOR NO REASON BECOME THE CAUSE OR THE MEANS BY WHICH LIFE IS BROUGHT TO A PREMATURE END.
4. THE COMMUNITY MUST GUARANTEE THE DYING THE EXERCISE OF ALL CIVIL RIGHTS, PARTICULARLY THE RIGHT OF VOTING AT HOME.
5. THE COMMUNITY MUST GUARANTEE THE DYING AND HIS FAMILY THE RIGHT OF CONTINUING A BALANCED RELATIONSHIP WITH THE ENVIRONMENT
6. THE COMMUNITY MUST GUARANTEE THE DYING AND HIS FAMILY THE FREEDOM OF DECIDING HIS FUTURE IN COMPLETE RESPECT OF EUBIOSIA AND ITS KNOWLEDGE
7. IT IS THE COMMUNITY'S DUTY TO GUARANTEE FREE, CONTINUOUS AND SPECIALIZED TREATMENT FOR THE TERMINAL-ILL PERSON.
8. THE COMMUNITY MUST GUARANTEE THE DYING A UNIFORM LEVEL OF ASSISTANCE, WHICH MATCHES THE NEEDS IN EVERY RESPECT
9. THE DYING PERSON IS ENTITLED TO CHOOSE FREELY WHETHER TO BE TREATED AT HOME OR IN HOSPITAL.
10. THE COMMUNITY MUST GUARANTEE THE DYING TO CHOOSE THE HEALTH STAFF WHO WILL CARE FOR HIM, IN TOTAL COMPLIANCE WITH STANDARDS OF PROFESSIONAL DIGNITY AND DEONTOLOGICAL CODES.
